## 13 2017/18 WORK PROGRAMME UPDATE

Paper A/4248/17

The report was presented by the Chief Executive, where he updated Members that:

- We've had 12 expressions of interest for Picketts Lock. Officers will short list this to 4 and report to Members in a couple of weeks' time.
- The concept design for the Ice Centre has been worked through. We are currently at the pre-application stage and in talks with London Borough of Waltham Forest regarding enabling development. We have recently committed £0.5 million for a new ice rink which is providing the best ice in London.
- There has been lots of participation in the Community Access Fund, especially with people from non-riparian boroughs and a full report will be bought to Members at the end of the year.
- It is the 7<sup>th'</sup> year for the Schools Festival at Lee Valley White Water Centre and the 4<sup>th</sup> year at the Lee Valley Hockey & Tennis Centre, where there has been good attendance from both riparian and non-riparian schools.
- Wild Camping was launched this year and has already received 1000 visitors, 50% of whom are from non-riparian boroughs.

A Member asked if the issues with East India Dock Basin were still ongoing. Officers replied that two of the biggest issues were with silt and the lock gates. Officers are working with London Borough of Tower Hamlets to see if CIL funding was available for these issues from large developments in the area. If the Authority were to receive CIL funding it would help to make a more compelling case for Heritage Lottery Funding. Trinity Buoy Wharf's plan to site the SS Robin ship at East India Dock Basin has been put on hold until we understand more about the lock gates.

A Member reminded everyone that we must not get too distracted by our large venues and remember the great work that our rangers achieve and that our Parklands are a great asset too.

A Member asked if Mayors and Chief Executives were invited to the schools festival. Officers replied that Leaders are invited and encouraged to pass their invites on to other colleagues if they are unable to attend.

A Member pointed out that the Park Development Framework had been going on for a long time and asked what the original schedule was for it. Officers replied that it was paused due to judicial reviews that were taking place, complaints around glasshouses and our Land & Property Strategy, it has now been restarted and on schedule.

A Member stated that he would like to see the land highlighted for disposal in Land & Property Strategy in the work programme.

In addition John Bevan will not receive papers from any Authority meeting on issues relating to the re-commissioning of the new Leisure Services Contract, management fee or external procurements where the Trust has submitted a proposal.
