731 DECLARATIONS OF INTEREST

732 PUBLIC SPEAKING

Jimmy Russo, Valley Grown Nurseries Ltd, addressed the Committee, including:

- did the Authority believe that its remit included the destruction of the glasshouse business as the Lee Valley Leisure Trust's Chairman did not;
- the Authority's continuous attempts to have agricultural buildings defined as industrial buildings had been costly to the tax payer and Valley Grown Nurseries;
- there was no legal basis for the Authority's challenge and it would be better served by action outside of the courts such as lobbying for changes to the National Planning Policy Framework:
- the Authority's case had been dismissed by 4 judges and Lord Justice Lindblom had set out in the judgment the position of horticultural buildings in the Green Belt; and
- in his opinion inclusion within Park Development Framework proposals of compulsory purchase of glasshouses in Paynes Lane had been detrimental to his business and in his view the reason for doing so was questionable.

The Chairman thanked Mr Russo for his presentation and drew Members attention to the previously circulated letter, dated 9 May 2016, from the Secretary of the Lea Valley Growers Association.
